2024 PINSETTERS OF FLORIDA 35TH ANNUAL LADIES HANDICAP TOURNAMENT RULES

1. **PARTICIPATION** - Any female USBC Bowler may enter. Two professional bowlers may bowl on a team, but not together as doubles.
2. **DOUBLES/SINGLES EVENTS** - Bowlers entering doubles must enter singles and vice versa. Doubles and Singles will be bowled on the same pair of lanes, unless you elect to do Derived Singles (using your doubles game scores for your single game scores). You may enter Doubles & Singles only once. Doubles will be bowled first.
3. **TEAM EVENT** - Bowlers may enter the 4-member team event on more than one team, but no more than two members may bowl together on the same team. First team score bowled counts toward All Events score. If teams wish to bowl each other, please indicate on entry form. List names on entry form in order they are to bowl. No position changes will be allowed in the line-up.
4. **SUBSTITUTIONS** - Substitutions will be allowed and must be made at least one hour prior to the schedule bowling time with verification of average. Substitutes shall take the place of the original entrant. Substitutes will be entitled to any prize monies or awards earned from her competition. Substitutes will not be liable for any reimbursement of entry fees, prize money or awards to the original entrants. Paid All Events are not transferable unless substitute replaces original entrant in all three events.
5. **AVERAGES** - Entrants shall use her highest USBC certified league average as of the end of the 2022-2023 season based on a minimum of 21 games. If no 2022-2023 average was established, entrants shall use her highest 2021-2022 average based on 21 games or more. If no average was established or the average cannot be verified, entrant shall use her highest current USBC league average of 21 games or more as of June, 2023. Entrants must use her highest USBC average regardless of whether bowled as a regular member or a substitute. Verified average change must be submitted prior to bowling. Entrants not qualifying under these rules may bowl scratch. Bowlers are responsible for making sure their average is correct. Incorrect average used will disqualify bowler. USBC Rules 319A2, D, & E DO NOT apply. Rule 319C will apply.
6. **HANDICAP** - Handicap will be 90% of difference between the entrants highest USBC average and 220.
7. Entries close midnight July 20, 2024. All entries postmarked the first post office business day after the closing date shall be accepted. After an entry has been accepted by the Tournament manager, entry fees **cannot** be refunded. The Tournament Manager reserves the right to reject any and return any entry fees.
8. Entrants shall be scheduled on a first come first serve basis. Teams doubling together should send entries and fees in one envelope.
9. Entrants of any event not paired with other entrants shall bowl as though contested. Anchor bowler must have completed her frame on one lane before lead -off bowler begins the next frame.
10. **PRIZE FUND RETURNED** 100% - The prize ratio will be a 1-6 ratio for Team, Doubles, and Singles events. A 1-10 ratio will be used for both Handicap and Scratch All Events.
11. ALL PRIZE FUND CHECKS will be mailed 30 days after tournament close.
12. Any protests affecting eligibility, average, or general playing rules shall be governed by USBC Rule 329.
13. **DRESS CODE** - Entrants are required to wear suitable attire when participating in this Tournament. There will be NO HALTER TOPS, TANK TOPS, CROP TOPS, OR SHORT SHORTS ALLOWED.
14. Any rules not listed for this tournament will be covered by USBC rules.
