PINSETTERS OF FL 4th ANNUAL MIXED TEAMS TOURNAMENT RULES

THIS TOURNAMENT IS USBC SANCTIONED AND ALL RULES WILL BE OBSERVED. All participants must have a current USBC card.

The tournament is open to all bowlers. Team Event – (4) bowlers per team, consisting of 2 males and 2 females, or 3 males and 1 female, or 3 females and 1 male. Teams will bowl (3) games. Handicap shall be 90% of 230. Entrants shall use his/her highest USBC certified league average as of the end of the 2022-2023 season based on a minimum of 21 games. If no 2022-2023 average was established, entrants shall use his/her highest 2021-2022 average based on 21 games or more. If no average was established or the average cannot be verified, entrant shall use his/her highest current USBC league average of 21 games or more. Entrants must use his/her highest USBC average regardless of whether bowled as a regular member or a substitute. Verified average change must be submitted prior to bowling. Entrants not qualifying under these rules may bowl scratch with an average of 230. BOWLERS ARE RESPONSIBLE FOR MAKING SURE THEIR AVERAGE IS CORRECT. Ten-pin rule will apply in computing entering averages. USBC Rules 319A2, D, & E DO NOT apply. Rule 319C will apply. *Only two pro-bowlers per team allowed*

The Team's entry fee per bowler is \$45.00, or \$180.00 per team entry. Of the \$45.00 entry fee, \$30.00 is allotted for the prize fund, and \$15.00 is allotted for lineage and expenses. PRIZE FUND RETURNED 100% - The prize ratio will be 1 of 6 will cash. **Teams are allowed to have multiple entries as long as one person on the team has changed.** Total pins plus handicap will determine standings from 1st place to the final paid position. Teams that cash will have 4 individual checks mailed to their Team Captain for distribution. All prize fund checks will be mailed 30 days after tournament closes. **(ALL CHECKS MUST BE CASHED WITHIN 30 DAYS OF DATE ON CHECK)**

Bowlers have the option to participate in the Handicap Singles or Scratch Singles event while bowling their Team event. There will be male and female divisions for both single optional events. All optional fees will be applied toward the optional prize fund 100%. Of the total entries 1 of 4 will cash. Bowlers may cash multiple times. **All optional events must be paid by April 17, 2024. No optional events will be accepted the day of the event.**

List names on entry form in the order they are to bowl. **No position changes will be allowed in the line-up.** Substitutions will be allowed and must be made at least one hour prior to the scheduled bowling time with verification of average. A man has to substitute for a man and a woman has to substitute for a woman. Substitutes shall take the place of the original entrant. Substitutes will be entitled to any prize monies or awards earned from the competition. Substitutes will not be liable for any reimbursement of entry fees, prize money or awards to the original entrants.

Entries are accepted on a first come, first served bases. Entries close midnight April 17, 2024. All entries postmarked the first post office business day after the closing date shall be accepted. After an entry has been accepted by the Tournament manager, entry fees cannot be refunded. The Tournament Manager reserves the right to reject any and return any entry fees. Any protests affecting eligibility, average, or general playing rules shall be governed by USBC Rule 329. **PLEASE CALL OUR MESSAGE PHONE NUMBER FOR UNANSWERED QUESTIONS (407)367-9173.**

Tele score printouts will be the official scores. Scores lost due to power outage or mechanical failure must be re-bowled.
